Show Dates & Hours: Vendors must be checked in and set up no later than end of day, Wednesday, Feb 2nd, 2022. All booths must remain open until closing on Sunday, February 6, 2022. (Approximately 3:00 pm). Failure to do so may result in the rejection of future applications.

No vehicles will be allowed in the building after 7:00pm Wednesday, February 2nd, 2022. (Including Rvs and stock vehicles.) Roll up doors will not be open after 7:00pm, Wednesday, Feb 2nd 2022. Exhibitors are required to report to show management to verify space assignment prior to set-up.

Exhibit Move In : Vendors may begin as early as Monday, January 31, 2022, with prior approval from Trade Show Committee. Vendors will be open during hours of operation as follows:
Thursday/ Friday/Saturday: 9:00am – 8:00pm and Sunday: 9:00am – 3:00pm

During dismantling, exhibitor will be expected to remove all trash and debris from their exhibit area and place it in the trash containers provided by the committee. Any articles or materials not removed from the ground by 5:00 pm on Monday, February 7th, 2022 will become the sole property of the show. The committee reserves the right to dispose of such property in any manner it may deem in the best interests of the show.

Exhibitors: Space will be assigned upon approval of application, after Jan 15th, 2022. Payment for space is required with application. No exhibitor will be allowed to move in to booth space without full payment. No personal checks will be accepted after January 15, 2022. Fees must be paid in cash, credit card, money order or cashiers check after this date. Every credit card transactions will be charged a nominal bank fee of 3%.

PASSES: Each exhibitor will receive (2) admission passes per 10'x10' booth space. More may be given, if needed, at the discretion of the Vendor Chairman, Garrett or Cameron Duncan. Passes will be required for admission during Saturday Night Ranch Rodeo performances.

Booth Furnishings: Exhibitors must provide their own booth materials and supplies, such as decorations, backdrops, display cases, etc. One (1) table per 10'x10' space will be provided at no additional charge. Additional tables are available upon request.

Refund & Cancellation Policy: All exhibitors are expected to conduct themselves in a professional manner, according to the rules of this agreement. Any unruly conduct, refusal to follow rules, or use of foul language to Event patrons or Committee members will be considered grounds for expulsion. NO REFUNDS.

Event Security: The Klamath Bull & Horse Sale will retain the services of security personnel for the purpose of grounds security. Security will be provided Wednesday evening through Sunday.

General Rules:

A. Sound devices, including, but not limited to loud speakers, organs, pianos, radios, are subject to approval by Committee, and if allowed, must be controlled so as not to interfere with others. The privilege for use of such sound devices may be revoked at any time.

B. The show is open to the public, and exhibitors must care for and keep in good order the space occupied by them, taking every precaution against possible injury to visitors, guests, and employees.

C. Placing advertising material on or in automobiles is specifically prohibited and no permission for such distribution will be granted under any circumstances.

D. The committee reserves the right to refuse exhibitis which would in any way detract from the dignity of the Show.
